DISSERTATION SUMMARY: In *Knowing How to Feel: Epistemic Oppression and Affective Resistance*, I explore ways of resisting harmful 'epistemic resilience,' or the phenomenon whereby shared systems of meaning remain stable despite counter-evidence or attempts to alter them. According to my view, we best resist 'affectively,' or by targeting how we *feel* or *fail to feel* towards others, and especially towards those who possess the alternative resources of meaning required for deep transformation. I show that some kinds of emotional engagement through art can affectively resist harmful resilience through countering "affective numbness."
